



Assume I deposited \$5000 into a money market account that paid 4% per year compound interest. Five years later, I withdrew all of the money from the account. At that point, it totaled

$$\$5000 (1.04)^5 = \$6083$$

Draw the cash flow diagram from *my* perspective and the *bank's* perspective.
