Scholarship Example 1 (Capitalized Cost)



A wealthy donor wants to create an endowment to provide scholarships to first-generation engineering students. She wants to fund five \$10,000 scholarships each year beginning two years from now.

Assuming an interest rate of 5% per year (a commonly used value for such endowments) how much must she donate today?
